ORDER

In exercise of the powers conferred upon the Chief Inspector under Regulation 2(d) of the **Dock Workers (Safety, Health and Welfare) Regulations, 1990**, Shri Aniket C. Palshikar, Deputy Manager, M/s. Bharat Wire Ropes Limited, Chalisgaon is approved as “Competent Person” under the provisions of the **Dock Workers (Safety, Health and Welfare) Regulations, 1990** for the **Major Ports of India** for the purposes of testing, examination and certification of **Wire Ropes and Wire Rope Slings** manufactured by **M/s. Bharat Wire Ropes Limited, Chalisgaon** only for a period of **two years** from the date of issue of this order subject to the following conditions:

1. The testing establishment shall submit certificates in respect of calibration of the equipment used for testing purposes to the **Dock Safety Inspectorates (HQ), DGFASLI, Mumbai** by **31st March every year**.
2. The “Competent Person” shall be **physically present** at the time of testing and examination.
3. The “Competent Person” shall inform the **Dock Safety Inspectorates (HQ), DGFASLI, Mumbai** about the date, time and venue of the test and examination to be carried out by him, well in advance.
4. Monthly Statement in the prescribed format regarding the test and examination certificates issued by him shall also be submitted to the **Dock Safety Inspectorates (HQ), DGFASLI, Mumbai** by **10th of following month**.
5. The “Competent Person” is permitted to carry out the testing of **Wire Ropes and Wire Rope Slings manufactured by M/s. Bharat Wire Ropes Limited, Chalisgaon** only upto a maximum test load of **480 tonnes** in the declared testing establishment.
6. The competency may be **revoked** by the declaring authority at any time without assigning any reason. The competency will **cease** on **09.06.2027** after the office working hours or from the date of the competent person leaving the organisation or from the date of revocation of this order, whichever is earlier.
7. The Competent Person desiring to seek renewal shall apply at least 60 days before the expiry of his competency.
